The applicant is requesting approval to rezone approximately 445.29 acres from LDR (Low Density Residential) to NHC (Neighborhood Highway Commercial). The request is intended to allow for small retail uses, including items such as retail, hardware store, softball facility, and camping-related uses.

The Planning Commission reviewed the request and recommended denial at its November 17, 2025 meeting.

County staff reviewed the request and identified conditions that could be applied if the Board chooses to approve the rezoning, including limitations on use, compliance with applicable codes, and requirements for final site and layout approval prior to development.

Commissioners,

A date needs to be established for the public hearing regarding the proposed ordinance change allowing 2-acre lots. Staff has been working on the required revisions to the ordinance and needs adequate time to finalize the document for legal review. Following legal review, the County must provide public notice of the hearing for a minimum of 15 days and a maximum of 45 days.

Staff recommends setting the public hearing for March 24, 2026, at 6:00 p.m. This date allows sufficient time to complete the necessary ordinance revisions, obtain legal review, and provide proper public notice.

Subject: Update on Revisions of Lease Agreement between Public Service Towers Inc. (PSC)

Commissioners,

PSC has responded with two proposed revisions that they are not willing to modify. The first revision concerns the venue for any disputes; PSC requests that the venue remain in Taylor County or a neighboring county. Legal has advised that litigation could occur in any county, but Meriwether County is preferred.

The second revision relates to Item 29(j), which addresses consequential damages. The proposed work will not occur within the existing fenced area. Instead, a secondary fence will be constructed outside the current perimeter to house the power equipment required for the tower.

Staff recommends approval of the contract with the venue set in Taylor County, acceptance of Item 29(j) as written, and authorization for the Chairman or Vice-Chair to execute the agreement.







Commissioners,

Max Plumbing is currently performing repairs on the Meriwether County sanitary sewer lines at the Jail and has discovered additional damage to the sanitary line connected to the grease trap. This line consists of older metal piping and is in need of repair.

Since Max Plumbing is already working in the area and has provided a repair quote of \$19,929.00, and because the company has agreed to the previously established terms requested by legal counsel, staff recommends allowing Max Plumbing to complete this additional work in conjunction with the existing project.

Funding for this repair will be provided through SPLOST.

Staff recommends approval of this request and authorization for the Chair or Vice-Chair to execute the agreement.

Subject: Approval of Grinder Station Replacement for Main Sewer Line at Meriwether County Jail

Commissioners,

The existing grinder station currently in service is no longer effectively addressing foreign material issues at the County Farm lift station, which flows to the Greenville Wastewater Treatment Plant. To resolve this issue, a new manual bar screen will be installed as a sealed unit to isolate the water flow. This system will prevent debris from bypassing the screening process and significantly reduce the number of debris entering the waste channel without being properly screened.

The cost of the system is \$19,400.00, with funding to be provided through SPLOST.

Staff recommends approval of this request and authorization for Environmental Instrumentation and Calibration to install the required equipment.
